Financial Assistance Guidelines

- Financial assistance is only available to DuPage County residents.
- Your combined household annual adjusted gross income cannot exceed \$80,000.
- Financial assistance is only available for summer camps or for archery, boating, family camping, model craft, off-leash dog area, picnicking, or special-use permit fees.
- Financial assistance is limited to a 50% discount for one summer camp session per child per calendar year or for one permit per household per calendar year.
- Applications for the 2025 calendar year will be accepted beginning Dec. 1, 2024. **This application is valid for the 2025 calendar year only.** You must reapply each year.
- Summer camp and permit fees are subject to change at any time.

Required Documents

With this application you must also submit:

- 2023 IRS tax returns for each adult in the household showing your adjusted household gross income and (if applicable) any dependents
- One of the following: social security card, Section 8 form, government aid form, or medical aid form or card
- The three most recent pay or unemployment stubs for each adult in the household
- An explanation of how this program will benefit you and your family as well as any additional information, unusual expenses, or extenuating circumstances that are not included in the application (e.g. financial, medical, disability, etc.)

You can submit your completed application and documents one of three ways:
