Dear friends,

The Friends of the Forest Preserve District of DuPage County, a 501(c)(3) nonprofit organization, welcomes gifts at every level to advance the Forest Preserve District's mission "to acquire and hold lands for the purpose of preserving the flora, fauna, and scenic beauty for the education, pleasure, and recreation of DuPage County citizens." It is our pleasure to extend a heartfelt thank you for your generous contributions in 2023. Your involvement makes a difference.

Informed citizens, like you, recognize the value of healthy ecosystems and outdoor recreation close to home. You may know that a large share of the revenue the District depends on for its operations comes from DuPage County real estate taxes (in 2024, taxes account for 64% of District budgeted revenue). For every dollar paid by DuPage residents, fewer than 2 cents comes to the Forest Preserve District. User fees, investment income, grants, and donations help supplement tax revenue to care for the forest preserves we all know and love. Together, we are protecting clean air and water, improving wildlife habitat, and sustaining our quality of life. Your contributions matter.

It is an ongoing challenge to care for nearly 26,000 acres of forest preserve land, operate seven education centers, and maintain the network of trails and amenities that make nature-based recreation enjoyable and accessible. It is a challenge that has grown since the District's founding in 1915, as land holdings and visitation increased. The District rises to this challenge thanks to dedicated efforts by its leaders, staff, volunteers, and friends.



The Friends of the Forest Preserve District hosted two informational sessions about the Willowbrook Wildlife Center master plan and opportunities for donors and community partners to support the project.

At the "Stewardship for the Birds" program, Bob Fisher, Forest Preserve District volunteer, and other DuPage Birding Club experts, introduced donors to the research behind how habitat restoration benefits bird populations at DuPage forest preserves.

The Native Plant Presale at Mayslake Peabody Estate in Oak Brook provided a ticketed opportunity to shop for native flowers, grasses, shrubs, and trees.

The "Friends Forest Tours" kicked off in August with Mike Dyer, board member of the Friends. The monthly hike continues to bring folks together to enjoy exercise and camaraderi at forest preserves.

We hosted "A Walking Tour of Springbrook Prairie Nature Preserve," a guided hike to celebrate the 60th anniversary of the Illinois Nature Preserves system. The hike was just one of 25 hikes and other activities at dozens of nature preserves across the state.

At the "Blanding's Turtle Sundaes & Social Hour," Dan Thompson, ecologist with the Forest Preserve District, featured highlights from the head-start program, followed by conversation over ice cream.







At our signature duck race, over 200 rubber ducks raced to raise funds in support of habitat restoration and native wildlife.

Donors, community partners, and fellow nature enthusiasts came together at "A Night for Nature" to raise funds for wild areas and wildlife in DuPage forest preserves.

Our Ambassadors Circle donors enjoyed a special reception at the Fall Festival at Danada. While there, we also recruited some help for the wild animals under Willowbrook Wildlife Center's care by making snuffle mats for enrichment purposes and collecting much-needed items from the center's wish list.

Giving Tuesday kicked off the season of giving with a \$4,000 matching challenge by the Friends of the Forest Preserve District's board, demonstrating its commitment to caring for DuPage forest preserves and providing access to nature to all who love it.
