



<u>VOLUNTEER PROGRAM:</u>	FULLERSBURG WOODS
<u>POSITION TITLE:</u>	Animal Care (or Family Program)
<u>COMMITMENT:</u>	Year-round Weekly (2 - 4 hrs/wk)
<u>LOCATION:</u>	Fullersburg Woods Campus, Oak Brook IL
<u>APPLICATION DEADLINE:</u>	None
<u>MINIMUM AGE:</u>	16 or 10 yrs + adult

DISTINGUISHING FEATURES OF THE POSITION

This position involves assisting staff in the care, feeding, and safe-keeping of a variety of native wildlife at the Fullersburg Woods Visitor Center, including the bird-feeders. There may be situations and tasks where the volunteer will interact with the public, and respond to questions and requests for information. Duties may vary at the discretion of the District staff. Direction and training is provided by staff.

PRIMARY VOLUNTEER DUTIES TO BE PERFORMED

- Assist staff in the care, feeding and safe-keeping of wildlife.
- Maintain indoor and outdoor animal habitats and supplies, including proper care and cleaning of equipment.
- Feed animals according to species requirements and in methods determined by staff. Administer special diets as directed by staff.
- Wash dishes, animal carriers, and towels as needed.
- Maintain habitats or equipment, such as monitoring environmental parameters (air, water and basking surface temp, water quality, humidity), and completing minor repairs.
- Assist with monitoring the health of animals, completing medical records and progress notes of animals.
- Fill, clean, and monitor bird feeders around buildings.
- Keep animal care areas, support areas, and equipment clean and well-organized.
- Work as a team with other volunteers or staff to assist with special projects and train new volunteers once established.
- Perform other duties as assigned.

SAFETY GUIDELINES

Safety guidelines must be followed by volunteers and will be communicated by staff. These may include volunteers wearing masks, wearing gloves, social distancing, and assisting with sanitizing supplies and equipment. Additional safety guidelines may be added for the safety of volunteers, staff, and the public.

REQUIRED KNOWLEDGE AND SKILLS

Required knowledge is provided at mandatory trainings and orientations. Volunteers will possess an interest in reptiles and amphibians and other native wildlife species. Interest in interacting with youth and families. Additional skills needed are: ability to interact positively and effectively with the public and staff, work independently and as part of a team, communicate effectively, make sound decisions, ability to use a variety of equipment and tools for habitat maintenance, ability to interpret and apply written and verbal instructions, willingness to learn from staff and accept feedback.

PHYSICAL DEMANDS

The physical demands described here are representative of what we ask volunteers to perform if able. While volunteering, the volunteer is regularly required to stand; walk; use hands to feel, finger or handle; reach with hands and arms; talk and hear. The volunteer is frequently required to climb, balance or stoop; kneel, crouch or crawl. The volunteer is occasionally required to sit. The volunteer is occasionally required to smell. The volunteer must regularly lift and/or move up to 25 pounds, occasionally lift and/or move up to 50 pounds. Specific vision abilities required by this position include close vision, distance vision, color vision, peripheral vision, depth perception and ability to adjust focus.

VOLUNTEER ENVIRONMENT

The volunteer environment characteristics described here are representative of those a volunteer encounters while performing the duties of the volunteer position.

While performing the duties of this volunteer position, the volunteer is sometimes exposed to outside weather conditions. The volunteer is occasionally exposed to high & precarious places and fumes or airborne particles, including allergens. The volunteer is occasionally exposed to wet and/or humid conditions. The noise level in the work environment is moderate. The volunteer occasionally performs duties in dim or low light.

PROVISIONS

This is an unpaid volunteer position, which exists to assist staff and to provide supplemental support for the District's programs. This position is undertaken freely on the part of the volunteer with no payment or expectation of payment of salaries, wages, compensation or other types of benefits. The District may from time to time alter or terminate volunteer positions and programs. Volunteer status may be changed or discontinued by the District at any time and for any reason, including a volunteer's failure to comply with District ordinances, policies and direction governing conduct in the performance of volunteer duties in the field or on District premises.

PURPOSE

The purpose of Volunteer Services Program at the Forest Preserve District of DuPage County is to engage volunteers who are willing to donate their time, talents and resources to support the programs and staff in carrying out the mission, purpose, and guiding principles of the Forest Preserve District of DuPage County and the volunteer programs.
